## PROJECT: PROVISION OF SECURITY SERVICES (2018)

## **SECTION I. INVITATION TO BID**

- 1. The Professional Regulation Commission (PRC) Tacloban Regional Office intends to apply the sum of SEVEN HUNDRED FIVE THOUSAND TWO HUNDRED PESOS (Php705,200.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Security Services for the year 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Professional Regulation Commission Tacloban Regional Office now invites bids for Procurement of Security Services. Security Services contract starts in \_\_\_\_\_\_\_, 2018. Bidders should have completed for the past two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. A complete set of Bidding Documents may be purchased by interested Bidders starting on March 13, 2018 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ONE THOUSAND PESOS (Php1,000.00)
- 5. Bids must be delivered to the address below on or before April 2, 2018, 5:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
  - OPENING AND PRELIMINARY EXAMINATION OF BIDS shall be on April 3, 2018 at 8:30 AM at the Office of the OIC Regional Director, PRC Tacloban City Regional Office, 2<sup>nd</sup> Floor Uytingkoc Bldg., Senator Enage St., Tacloban City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. LATE BIDS SHALL NOT BE ACCEPTED.
