- Check or verify your school/building assignments at the PRC official website ([www.prc.gov.ph](http://www.prc.gov.ph)) or through the Notices/Announcements to be posted at the PRC premises two (2) to three (3) working days before the date of the examination. Bring your NOTICE OF ADMISSION when you verify your school/building assignment. Visit your school/building assignment prior to the day of the examination.
- Report to the school/building assignment before 5:30 A.M. on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
- Examinees are required to wear the following attire every examination day:
 

Male Examinees	-	Tucked-in white polo shirt with collar (without any seal, logo or mark), decent pants or slacks
Female Examinees	-	Tucked-in white blouse or shirts with collar (without any seal, logo or mark), decent pants, slacks or skirt, pony-tailed long hair
- Bring the following on the examination day:
  - Notice of Admission
  - Official Receipt
  - Two (2) or more pencils (No. 2)
  - Pens with **BLACK** ink only
  - One (1) piece Long Brown Envelope
  - One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your valuables and other allowed items)
  - HORSESHOE MICROSCOPE OR MAGNIFYING GLASS**

5. The following items are strictly **PROHIBITED** inside the examination premises/rooms:

- a. Books, notes, review materials, and other printed materials containing coded data/information/formula
- b. **ALL KINDS OF CALCULATOR**
- c. **APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, BLUETOOTH, TRANSMITTERS, PORTABLE COMPUTERS, AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSE**
- d. Bags of any kind (place your documents inside the transparent/plastic envelope)
- e. Other examination aides not stated in this program

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, an inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

6. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)<sup>1</sup> throughout the conduct of the examination

7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.


