Relative to this, all examinees of Davao City are required to bring the following:

1. **Notice of Admission**
2. **Two (2) or more pencils (No. 2)**
3. **Ball pens with BLACK ink only**
4. **One (1) piece long size brown envelope**
5. **One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)**
6. **One (1) piece mailing envelope**
7. **Basic calculator which only contains the keys for the basic functions (+, -, x, and /). It may also have the memory keys (M+, M-, MR, MC, and $\sqrt{\quad}$)**
8. **For pregnant examinee, submit clearance from the OB-Gynecologists**
 - ❖ **Clearance should indicate that the examinee is cleared to take the licensure examination.**
 - ❖ **No OB-Gyne Clearance, No Exam.**
9. **Snacks and lunch packed in transparent containers.**
 - ❖ **Food deliveries are not allowed.**
 - ❖ **Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.**

IMPORTANT REMINDERS

1. **Examinees are prohibited to use cellular phone, ear plugs, bluetooth, and other electronic gadgets/devices. Examinees will be required to **TURN OFF** their mobile phone/s before entering the examination venue. Phone/s must be placed inside their bags and can only be used again upon exiting the venue;**
2. **Books, notes, review materials, and other printed materials containing coded data/information/formula are not allowed inside the testing center premises. Bringing of the said items inside the examination venue will be considered as **CHEATING** or an **ACT OF DISHONESTY**. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examinations.**
3. **Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools.**
4. **Personal belongings brought by an examinee shall be for his/her own account. The PRC will not be answerable for any such item or personal belonging that might be lost during the examination without fault or negligence on its part.**
