Resolution No. 2021 - 64(B)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF ONE THOUSAND (1000) LICENSE FOR CLOUD ENDPOINT SECURITY SOLUTION TO IMAX TECHNOLOGIES INC. WITH A TOTAL BID AMOUNT OF NINE HUNDRED TWENTY-FOUR THOUSAND PESOS (PHP924,000.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement of One Thousand (1,000) License for Cloud Endpoint Security Solution with an approved budget for the contract of Nine Hundred Ninety-Two Thousand Two Hundred Fifty Pesos (Php992,250.00).

WHEREAS, on October 15, 2021, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on October 29, 2021 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by two (2) prospective bidders, namely: Tiger Consulting and Software Devt Inc. and Imax Technologies Inc. (Imax). Only Imax purchased the Bidding Documents.

WHEREAS, On November 2, 2021, the BAC issued Bid Bulletin No. 1 (Annex "A") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference, and change on the date of Submission and Opening of bids from November 10, 2021 to November 11, 2021.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on November 11, 2021, during the submission and opening of bids, only Imax submitted its bidding document. The BAC, using a non-discretionary "pass/fail" criterion, Imax passed the eligibility and technical evaluation. Imax's financial bid was opened and its bid proposal is in the amount of Nine Hundred Twenty-Four Thousand Pesos (Php924,000.00). Thus, Imax was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

WHEREAS, on November 15, 2021, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4th Floor of the PRC Annex Building and via Video Conferencing.

WHEREAS, during the post-qualification, Imax was not able to present the original copies of the eligibility and technical documents submitted during the opening of bids, including the additional requirements for post qualification. Imax, stated that they have sent an email (Annex "B") requesting for extension of post-qualification due to none availability of original Notice of Award / PO attached in their all ongoing government and private contracts. Thus, the BAC instructed that they have to submit the additional requirements for the post-qualification on November 16, 2021.

WHEREAS, on November 16, 2021, during the post-qualification evaluation, Imax was not able to present the original attachments of their all ongoing government and private contract, stating that they have already requested the original copies of the said attachments and will be able to present them to the BAC. Thus, the BAC gave Imax three (3) calendar days to present the said compliance on November 18, 2021.


WHEREAS, on November 18, 2021, Imax was able to present to the BAC the original attachments for their all ongoing government and private contracts.

WHEREAS, Imax having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF ONE THOUSAND (1000) LICENSE FOR CLOUD ENDPOINT SECURITY SOLUTION TO IMAX TECHNOLOGIES INC** with the bid amount of **NINE HUNDRED TWENTY-FOUR THOUSAND PESOS (PHP924,000.00)**.
