**POST DISQUALIFICATION AND FAILURE OF BIDDING OF THE SINGLE
CALCULATED BIDDER FIBERCOM TELECOM PHILS INC FOR THE PROJECT
SUPPLY, DELIVERY, INSTALLATION, AND TESTING OF DATABASE FIREWALL
FOR THE DATABASE CLEANSING AND MANAGEMENT PROJECT**

WHEREAS, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply, Delivery, Installation and Testing of Database Firewall for the Database Cleansing and Management Project with an approved budget for the contract of Five Million Pesos (Php5,000,000.00).

WHEREAS, on October 19, 2021 the Bids and Award Committee (BAC) issued a Resolution No. 2021 – 47 dated October 19, 2021 recommending to the chairman of the Professional Regulation Commission (PRC) the extension of the conduct of post-qualification for the said project.

WHEREAS, during the post-qualification the BAC determined the submission and presentation of Fibercom Telcom Phils., Inc. as follows:

1. Failure to present the Audited Financial Statements of Fibercom Telecom Phils. Inc in compliance with the preceding calendar year which should not be earlier than two (2) years from the date of submission.
2. Failure to submit its Latest Income and Business Tax Returns in compliance within the last six months preceding the date of bid submission.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) No. 9184, states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;*
- b) All prospective bidders are declared ineligible;*
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)*

WHEREAS, in view of the foregoing considerations, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it is hereby **RESOLVED**, to **DECLARE FIBERCOM TELECOM PHILS. INC POST DISQUALIFIED AND THE FAILURE OF BIDDING FOR THE PROJECT SUPPLY, DELIVERY, INSTALLATION, AND TESTING OF DATABASE FIREWALL FOR THE DATABASE CLEANSING AND MANAGEMENT PROJECT.**


