Resolution No. 2021 - 02(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF COURIER SERVICES FOR CALENDAR YEAR 2021 FOR THE CENTRAL OFFICE TO THE REGIONAL OFFICES, SATELLITE OFFICES AND OFF SITE SERVICE CENTERS TO WIDE WIDE WORLD EXPRESS CORPORATION WITH TOTAL BID AMOUNT OF ONE MILLION TWO HUNDRED FOUR THOUSAND EIGHT HUNDRED PESOS (Php1,204,800.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement of Courier Services for Calendar Year 2021 for the Central Office to the Regional Offices, Satellite Offices and Off Site Service Centers with an approved budget for the contract of One Million Five Hundred Six Thousand Pesos (Php1,506,000.00) only.

WHEREAS, on October 21, 2020 a pre-bid conference was conducted. However, there is no bidder attended the meeting. Thus, the BAC issued a Bid Bulletin No. 1 to schedule a 2nd Pre-bid Conference for this project.

WHEREAS, on October 28, 2020, a 2nd Pre-bid Conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. Only Wide Wide World Express Corporation (W Express) attended the meeting. Consequently, only W Express purchased the Bidding Documents. As a result of the discussion, the BAC issued Bid Bulletin No. 2 reflecting the modifications/amendments to the Bidding Documents. On November 10, 2020, the BAC issued Bid Bulletin No. 3 for the rescheduling of Submission and Opening of Bids.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the submission and opening of bids on November 17, 2020, the BAC, using a non-discretionary "pass/fail" criterion, W Express passed the eligibility and technical evaluation. W Express financial bid was opened and its bid proposal is in the amount of One Million Two Hundred Four Thousand Eight Hundred Pesos (Php1,204,800.00). Thus, W Express was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

WHEREAS, on November 19, 2020, a post-qualification was conducted at PRC Conference Room, 2nd Floor, PRC Main Building to verify, validate, and ascertain all statements made in its Eligibility and Technical Bid Envelopes during the submission and opening of bids, including the additional requirements submitted by the bidder.

WHEREAS, W Express, having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF COURIER SERVICES FOR CALENDAR YEAR 2021 FOR THE CENTRAL OFFICE TO THE REGIONAL OFFICES, SATELLITE OFFICES AND OFF SITE SERVICE CENTERS TO WIDE WIDE WORLD EXPRESS CORPORATION** with bid amount of **ONE MILLION TWO HUNDRED FOUR THOUSAND EIGHT HUNDRED PESOS (Php1,204,800.00)**.
