## BIDS AND AWARDS COMMITTEE Resolution No. 2021 - <u>10(B)</u>

## RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF HARD DRIVE WITH TRAY COMPATIBLE WITH EXISTING STOREWISE V3700 FOR 2021 TO MACROLOGIC DIVERSIFIED TECHNOLOGIES INC. WITH ATOTAL BID AMOUNT OF SEVEN HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED PESOS (Php795,500.00)

**WHEREAS**, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement of Hard Drive with Tray Compatible with Existing Storewise V3700 for 2021 with an approved budget for the contract of Seven Hundred Ninety-Eight Thousand Pesos (Php798,000.00).

**WHEREAS**, on April 6, 2021, ten o'clock in the morning, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

**WHEREAS**, on May 10, 2021 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective bidder, Macrologic Diversified Technologies Inc (Macrologic). Only Macrologic purchased the Bidding Documents.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on May 24, 2021 during the submission and opening of bids, only Macrologic submitted its bidding document. The BAC, using a non-discretionary "pass/fail" criterion, Macrologic passed the eligibility and technical evaluation. Macrologic's financial bid was opened and its bid proposal is in the amount of Seven Hundred Ninety-Five Thousand Five Hundred Pesos (Php795,500.00). Thus, Macrologic was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

**WHEREAS**, on May 27, 2021, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4<sup>th</sup> Floor of the PRC Annex Building. Macrologic presented the original copies of the eligibility and technical documents submitted during the opening of bids, including the additional requirements for post qualification.

WHEREAS, Macrologic having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PROCUREMENT OF HARD DRIVE WITH TRAY COMPATIBLE WITH EXISTING STOREWISE V3700 FOR 2021 TO MACROLOGIC DIVERSIFIED TECHNOLOGIES INC. with the bid amount of SEVEN HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED PESOS (Php795,500.00).
