**Resolution No. 2021 - 04**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROVISION OF JANITORIAL SERVICES IN CENTRAL AND NCR OFFICE FOR CY 2021 TO D'TRIUMPH CLEANERS AND ALLIED SERVICES, INC. WITH THE TOTAL BID AMOUNT OF SEVEN MILLION NINE HUNDRED EIGHTY THOUSAND SIX HUNDRED NINETY PESOS AND THIRTY SIX CENTAVOS (Php.7,980,690.36)**

**WHEREAS**, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the PRC website, Philippine Government Electronic Procurement System (PhilGEPS) website, and in the BAC Bulletin Board for the project: Provision of Janitorial Services in Central and NCR Office with an approved budget for the contract of Eight Million Nine Hundred Sixty Four Thousand Five Hundred Twenty Nine Pesos (Php.8,964,529.00).

**WHEREAS**, on December 29, 2020, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by two (2) prospective bidders namely, D'Triumph Cleaners and Allied Services, Inc. (D'Triumph) and CMPT Manpower Services (CMPT), who also purchased the bid documents.

**WHEREAS**, on January 7, 2021, BAC issued Bid Bulletin No. 1 (Annex "A") to give clarification to the computation of Philippine Health Insurance Corporation (PhilHealth) Premiums and Social Security System (SSS) Premiums in compliance to the PhilHealth Circular 2019-0009 and SSS Circular No. 2020-033 respectively.

**WHEREAS**, on January 13, 2021, BAC issued Bid Bulletin No. 2 (Annex "B") in response to the Official Statement of PhilHealth that the previous three percent (3%) premium contribution will still be implemented instead of the three point five percent (3.5%) rate as previously posted in Bid Bulletin No. 1.

**WHEREAS**, on January 20, 2021 during the scheduled opening of bids, both bidders submitted their bids containing their eligibility, technical, and financial requirements;

**WHEREAS**, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, D' Triumph and CMPT having passed the eligibility and technical evaluation, the BAC opened their respective financial bid proposal, as follows:

1. D'Triumph - Seven Million Nine Hundred Eighty Thousand Six Hundred Ninety Pesos and Thirty Six Centavos (Php.7,980,690.36);
2. CMPT - Eight Million Seventy Eight Thousand Nine Hundred Twenty Pesos (Php.8,078,920.00)

**WHEREAS**, D' Triumph was declared to be the Lowest Calculated Bidder and was subjected to post-qualification on January 26, 2021.

**WHEREAS**, during the post qualification, the BAC verified, validated, and ascertained all statements made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical, and Financial Envelopes, including the additional documentary requirements that will be submitted by the said bidder during post-qualification.

**WHEREAS**, D'Triumph passed the post-qualification and was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROVISION OF JANITORIAL SERVICES IN CENTRAL AND NCR OFFICE FOR CY 2021 TO D'TRIUMPH CLEANERS AND ALLIED SERVICES, INC.** with a bid amount of **SEVEN MILLION NINE HUNDRED EIGHTY THOUSAND SIX HUNDRED NINETY PESOS AND THIRTY SIX CENTAVOS (Php.7,980,690.36)**
