## BIDS AND AWARDS COMMITTEE Resolution No. 2021 - 05

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF MANPOWER SERVICE PROVIDER FOR CY 2021 TO LSERV CORPORATION WITH A TOTAL BID AMOUNT OF EIGHTEEN MILLION FIVE HUNDRED SEVEN THOUSAND TWO HUNDRED SIXTY-FOUR PESOS AND EIGHTY-EIGHT CENTAVOS (Php18,507,264.88)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement of Manpower Service Provider for CY 2021 with an approved budget for the contract of Nineteen Million Three Hundred Fifty Two Thousand Four Hundred Thirty Eight and Sixty Eight Centavos (Php19,352,438.68).

**WHEREAS**, on February 23, 2021, ten o'clock in the morning, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on March 29, 2021 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by three (3) prospective bidders, LSERV Corporation (LSERV), Omniworx, Inc. (Omniworx), and Temps and Staffers Inc. (TSI). Only LSERV purchased the Bidding Documents.

**WHEREAS**, on April 07, 2021, the BAC issued Bid Bulletin No. 1 in regard to the PhilHealth premiums contribution and was posted in PhilGeps and PRC Website. (ANNEX A)

**WHEREAS**, during the submission and opening of bids on April 14, 2021, the BAC, using a non-discretionary "pass/fail" criterion, LSERV passed the eligibility and technical evaluation. LSERV's financial bid was opened and its bid proposal is in the amount of Eighteen Million Five Hundred Seven Thousand Two Hundred Sixty-Four Pesos and Eighty-Eight Centavos (Php18,507,264.88). Thus, LSERV was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

**WHEREAS**, on April 19, 2021, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4<sup>th</sup> Floor of the PRC Annex Building. LSERV presented the original copies of the eligibility and technical documents submitted during the opening of bids, including the additional requirements for post qualification.

**WHEREAS**, LSERV having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PROCUREMENT OF MANPOWER SERVICE PROVIDER TO LSERV CORPORATION with the bid amount of EIGHTEEN MILLION FIVE HUNDRED SEVEN THOUSAND TWO HUNDRED SIXTY-FOUR PESOS AND EIGHTY-EIGHT CENTAVOS (Php18,507,264.88).
