Resolution No. 2021 - 35

DECLARING OF FAILURE OF BIDDING FOR THE PROJECT: SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, AND TESTING OF VARIOUS IT EQUIPMENT – LOT 3 : SUPPLY AND DELIVERY OF ONE HUNDRED EIGHTEEN (118) UNITS OF LAPTOP WITH TOTAL APPROVED BUDGET FOR THE CONTRACT OF FIVE MILLION THREE HUNDRED EIGHTY THOUSAND NINE HUNDRED EIGHTEEN PESOS (PHP5,380,918.00)

WHEREAS, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply, Delivery, Installation, Configuration, and Testing of Various IT Equipment – Lot 3 : Supply and Delivery of One Hundred Eighteen (118) Units of Laptop with an approved budget for the contract of Five Million Three Hundred Eighty Thousand Nine Hundred Eighteen Pesos (Php5,380,918.00).

WHEREAS, on August 5, 2021 a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on August 27, 2021, a Pre-Bid Conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by six (6) prospective Bidders namely: Macrologic Diversified Technologies Inc. (Macrologic), DCI Int'l IT Solutions and Services Corp., The Value Systems Phils. Inc., Quartz Business Products Corp., Imax Technologies, and MCX International Inc.

WHEREAS, On September 1, 2021, the BAC issued Bid Bulletin No. 1 (Annex "A") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference, and re scheduling of submission and opening of bids from September 8, 2021 to September 10, 2021.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on September 10, 2021 during the submission and opening of bids, only Macrologic submitted its bidding documents. Upon evaluation thereof using the non-discretionary "pass/fail" criterion, BAC gave Macrologic a failed mark for not complying on the prescribed form for the Statement of Largest Completed Contract (SLCC).

WHEREAS, Macrologic manifested to file a Motion for Reconsideration (MR), which was later on withdrawn as shown in Annex "B". On this basis, the BAC disqualifies Macrologic for not complying with the prescribed format on SLCC.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) No. 9184, states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;**
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35 of the same RIRR also provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it is hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING** for the project: Supply, Delivery, Installation, Configuration, and Testing of Various IT Equipment – Lot 3 : Supply and Delivery of One Hundred Eighteen (118) Units of Laptop with total approved budget for the contract of **FIVE MILLION THREE HUNDRED EIGHTY THOUSAND NINE HUNDRED EIGHTEEN PESOS (PHP5,380,918.00)**. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
