Resolution No. 2021 - 03

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES IN CENTRAL AND NATIONAL CAPITAL REGION OFFICE FOR CY 2021 TO ABC-RMO SECURITY & INVESTIGATION AGENCY, INC. WITH A BID AMOUNT OF EIGHT MILLION FOUR HUNDRED ONE THOUSAND TWENTY PESOS AND ELEVEN CENTAVOS (Php8,401,020.11)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) and Philippine Government Electronic Procurement System (PhilGEPS) websites, and in the Bids and Awards Committee (BAC) Bulletin Board, for the project: Provision of Security Services in Central and National Capital Region Office for CY 2021 with an approved budget for the contract of Eight Million Seven Hundred Eighty Nine Thousand Six Hundred Ninety Two Pesos (Php8,789,692.00).

WHEREAS, on December 29, 2020, a pre-bid conference was held to explain and clarify the bidding documents, and to accommodate any inquiry which the bidders may have that was attended by two (2) prospective bidders namely, ABC-RMO Security & Investigation Agency, Inc. (ABC-RMO) and Lockheed Federal Security Agency, Inc. (Lockheed). ABC-RMO, Lockheed, and Superb Security and Investigation Agency, Inc. (Superb) purchased the bid documents.

WHEREAS, on January 7, 2021, BAC issued Bid Bulletin No. 1 (ANNEX A) on the clarification on the basis of computation of Philippine Health Insurance Corporation (PhilHealth) and Social Security System (SSS) premiums contribution, in compliance with the PhilHealth Circular 2019-0009 and SSS Circular No. 2020-033, respectively.

WHEREAS, on January 13, 2021, BAC issued Bid Bulletin No. 2 (ANNEX B) in response to the *Official Statement* of PhilHealth that the previous three percent (3%) premium contribution will still be implemented instead of the three point five percent (3.5%) rate as previously posted in Bid Bulletin No. 1.

WHEREAS, on January 20, 2021, during the deadline of submission and Opening of Bids, only ABC-RMO and Superb submitted their bids containing its eligibility, technical, and financial requirements.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the evaluation of bids, Superb failed to submit a copy of its Secretary's Certificate as to identity of their authorized representative to participate in all the bidding proceedings particularly during the Opening of Bids, and failed to identify the office designation of the representative in the acknowledgment part of Sections IV, V, VI and VII of the bidding documents.

WHEREAS, ABC-RMO passed the eligibility and technical evaluation, thus, the BAC opened its financial bid proposal amounting to **EIGHT MILLION FOUR HUNDRED ONE THOUSAND TWENTY PESOS AND ELEVEN CENTAVOS (Php8,401,020.11)**. Hence, ABC-RMO was declared to be the Single Calculated Bidder and was subjected to post-qualification on January 26, 2021.

WHEREAS, during the post qualification, the BAC verified, validated, and ascertained all statements made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that was submitted by the said bidder during post-qualification.

WHEREAS, ABC-RMO passed the post-qualification and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROVISION OF SECURITY SERVICES IN CENTRAL AND NCR OFFICE FOR CY 2021** to **ABC-RMO SECURITY & INVESTIGATION AGENCY, INC.** with the bid amount of **EIGHT MILLION FOUR HUNDRED ONE THOUSAND TWENTY PESOS AND ELEVEN CENTAVOS (Php8,401,020.11)**.
