ADOPTING THE CHANGE OF PARTNERSHIP NAME OF OCAMPO, MENDOZA, LEONG, LIM & CO. ON THE RECORDS OF PROFESSIONAL REGULATORY BOARD OF ACCOUNTANCY AND THE PROFESSIONAL REGULATION COMMISSION TO OCAMPO, MENDOZA, LIM AND CO. FOR THE PRACTICE OF PUBLIC ACCOUNTANCY

WHEREAS, the Professional Regulatory Board of Accountancy (Board) issued Resolution No. 235 dated December 4, 2015 approving the application of **OCAMPO, MENDOZA, LEONG, LIM & CO.** for the practice of public accountancy and was issued Certificate of Accreditation bearing No. 0737 valid until December 31, 2018 and was registered accordingly on the records of the Board and the Commission;

Upon approval hereof by the Commission and payment of the prescribed fees, let its Certificate of Accreditation bearing its partnership name of **OCAMPO, MENDOZA, LIM & CO.** be issued accordingly with the same accreditation no. and date of validity.

FURTHER RESOLVED, the Certificate of Accreditation under the partnership name of **OCAMPO, MENDOZA, LEONG, LIM & CO.** is hereby **CANCELLED**.


