RATIFICATION OF APPLICATIONS FOR THE ISSUANCE OF CERTIFICATES OF ACCREDITATION TO CPAs IN COMMERCE AND INDUSTRY PRACTICE APPROVED BY THE BOARD FOCAL PERSON FOR THE MONTH OF JUNE 2017

WHEREAS, Article II, Section 9 (g) of Republic Act (R.A.) No. 9298, otherwise known as the "Philippine Accountancy Act of 2004", empowers the Professional Regulatory Board of Accountancy to promulgate accounting and quality standards for the enhancement and maintenance of high professional, ethical, accounting and auditing standards;

WHEREAS, by virtue of this power, the Board issued Resolution No. 68 Series of 2016, entitled "Amending Resolution No. 03, Series of 2016, Requirement for the Submission of Certificate by the Responsible Certified Public Accountants on the Compilation Services for the Preparation of Financial Statements and Notes thereto, Mandating External Auditors to Monitor Compliance thereto, and for other Purposes", which requires accreditation of Certified Public Accountants (CPAs) engaged in Commerce and Industry practice;

WHEREAS, the Board issued Resolution No. 61, Series of 2017, entitled "Designation of Accreditation Board Focal Person" which provides that all applications approved by the Board Focal Person shall be subsequently ratified by the Board concerned, subject to further ratification by the Commission, through a Resolution passed for that purpose;

WHEREAS, **SAMUEL B. PADILLA**, or in his absence, **ARLYN S. VILLANUEVA**, has been appointed or designated as the Focal Person per Resolution No. 61, series of 2017;
