RATIFICATION OF APPLICATIONS FOR THE ACCREDITATION OF INDIVIDUAL CERTIFIED PUBLIC ACCOUNTANTS (CPAs), FIRMS AND PARTNERSHIPS IN THE PRACTICE OF PUBLIC ACCOUNTANCY APPROVED BY THE BOARD FOCAL PERSON FOR THE MONTH OF JULY 2017

WHEREAS, Article IV, Section 31 of Republic Act (R.A.) No. 9298, otherwise known as the "Philippine Accountancy Act of 2004", states that Certified Public Accountants (CPAs), firms and partnership of CPAs engaged in the practice of public accountancy, including partners and staff members thereof, shall be registered with the Commission and the Professional Regulatory Board of Accountancy (Board);

WHEREAS, Annex B of Board Resolution No. 71, Series of 2004, otherwise known as "The Rules and Regulations Implementing Republic Act No. 9298", provides for the rules and regulations on the accreditation of Individual CPAs, firms and partnerships of CPAs engaged in the practice of public accountancy;

WHEREAS, the Board issued Resolution No. 92, Series of 2016, entitled "Prescribing Revised Application Forms, Documentary Requirements, and New Fees for the Accreditation of Certified Public Accountants (CPAs) in a) Public Practice xx", which provides for the new application forms, documentary requirements and fees in the accreditation of Individual CPAs, firms and partnerships in the practice of public accountancy;

WHEREAS, the Board issued Resolution No. 5, Series of 2016, entitled "Prescribing Additional Requirements for the Initial Applications for and Renewal of Registration or Accreditation of Individual Certified Public Accountant, Firms and Partnerships of Certified Public Accountants Engaged in the Practice of Public Accountancy, Amending for the Purpose " Annex B" of Resolution No. 71, Series of 2004, or the Rules and Regulations Implementing Republic Act No. 9298, otherwise known as the Philippine Accountancy Act of 2004, and for other purposes", which requires visitation of the principal office of individual CPA, Firms or Partnerships of CPAs as part of the evaluation of the application for the said accreditation;

WHEREAS, the Board issued Resolution No. 61, Series of 2017, entitled "Designation of Accreditation Board Focal Person" which provides that all applications approved by the Board Focal Person shall be subsequently ratified by the Board concerned, subject to further ratification by the Commission, through a Resolution passed for that purpose;

WHEREAS, **GERARD B. SANVICTORES**, or in his absence, **GLORIA T. BAYSA**, has been appointed or designated as the Focal Person to approve applications for the said accreditation ;
