ENROLLING THE ADDITIONAL PARTNER OF R.G. MANABAT & CO. IN THE PRACTICE OF PUBLIC ACCOUNTANCY

WHEREAS, Article IV, Section 31 of Republic Act (R.A.) No. 9298, otherwise known as the "Philippine Accountancy Act of 2004", states that Certified Public Accountants (CPAs), firms and partnership of CPAs engaged in the practice of public accountancy, including partners and staff members thereof, shall be registered with the Commission and the Professional Regulatory Board of Accountancy (Board);

WHEREAS, Annex B of Board Resolution No. 71, Series of 2004, otherwise known as "The Rules and Regulations Implementing Republic Act No. 9298", provides for the rules and regulations on the accreditation of Individual CPAs, firms and partnerships of CPAs engaged in the practice of public accountancy;

WHEREAS, the Board issued Resolution No. 92, Series of 2016, entitled "Prescribing Revised Application Forms, Documentary Requirements, and New Fees for the Accreditation of Certified Public Accountants (CPAs) in a) Public Practice xx", which provides for the new application forms, documentary requirements and fees in the accreditation of Individual CPAs, firms and partnerships in the practice of public accountancy;

WHEREAS, the Board issued Resolution No. 83 dated March 10, 2017 approving the renewal of the Certificate of Accreditation of **R.G. MANABAT & CO.** for the practice of public accountancy and was issued the Certificate of Accreditation bearing No. 0003 dated March 10, 2017;

WHEREAS, on December 29, 2017, the **R.G. MANABAT & CO.** filed their application to enroll **RYAN EBON CABELLO, MARIA ARLEENE MORETO CATAPANG and JALLAIN MARCEL SESE MANRIQUE**, as additional partner;

WHEREAS, upon review of the documents submitted in support of their application, the Board finds that the requirements for enrollment of additional partners in the practice of public accountancy as set forth in Board Resolutions No. 2004-71 and No. 2016-92 have been satisfactorily met.

NOW THEREFORE, by virtue of the powers vested in it by R.A. No. 9298, the Board **RESOLVED**, as it so **RESOLVES**, to enroll their application of **RYAN EBON CABELLO, MARIA ARLEENE CATAPANG YU and JALLAIN MARCEL SESE MANRIQUE** as additional partner of **R.G. MANABAT & CO.** in the practice of public accountancy. Upon approval hereof by the Commission, let their additional partner be added in the list of partners of **R.G. MANABAT & CO.**
