**RECONSTITUTION OF THE CONTINUING PROFESSIONAL DEVELOPMENT COUNCIL  
(CPDC) FOR ACCOUNTANTS, AMENDING FOR THE PURPOSE BOARD  
RESOLUTION NO. 263, SERIES OF 2017**

**WHEREAS**, Republic Act No. 10912, otherwise known as the Continuing Professional Development Act of 2016, institutionalized the CPD requirement for all of the regulated professions;

**WHEREAS**, the Professional Regulation Commission (Commission) issued Resolution No. 1032, Series of 2017, on the Implementing Rules and Regulations (IRR) of Republic Act No. 10912, known as the "Continuing Professional Development (CPD) Act of 2016" on February 15, 2017;

**WHEREAS**, Section 7 of R. A. No. 10921 and Section 7 of PRC Resolution No. 1032, Series of 2017, provide for the composition of the CPD Council, namely, the Chairperson from the Board concerned; First (1<sup>st</sup>) Member from the Accredited Professional Organization/Accredited Integrated Professional Organization (APO/AIPO); and Second (2<sup>nd</sup>) Member from national the organization of deans or department heads of schools, colleges or universities offering any course requiring the licensure examination;

**WHEREAS**, the Professional Regulatory Board of Accountancy (Board) and the Commission issued Resolution No. 263, Series of 2017, creating the CPD Council for Accountants with the following members: **GERARD B. SANVICTORES**, Chairman; **JOSE M. IRENEO**, First (1<sup>st</sup>) Member; and **FERDINAND A. RODRIGUEZ**, Second (2<sup>nd</sup>) Member;

**WHEREAS**, the position of CPD Council Chairman was left vacant with the appointment of the replacement of **GERARD B. SANVICTORES** in the Board;

**WHEREAS**, **GLORIA T. BAYSA** has been chosen to assume the position as the new Chairperson of the CPD Council for Accountants;

**NOW THEREFORE**, the Board **RESOLVES**, as it is hereby **RESOLVED**, to reconstitute the CPD Council for Accountants by designating **GLORIA T. BAYSA**, **JOSE M. IRENEO** and **FERDINAND A. RODRIGUEZ** as its Chairperson, First (1<sup>st</sup>) Member and Second (2<sup>nd</sup>) Member, respectively;

**FURTHER RESOLVED**, that the members of the CPD Council for Accountants herein constituted be directed to perform or exercise their powers and functions in accordance with Section 8 of Resolution No. 10912 and Section 8 of Resolution No. 1032, Series of 2017, after they shall have taken their oaths of office.


