**DESIGNATION OF SPECIAL TEMPORARY PERMIT (STP)
BOARD FOCAL PERSON, AMENDING FOR THE PURPOSE
BOARD RESOLUTION NO. 01, SERIES OF 2017**

WHEREAS, the Professional Regulation Commission (Commission) issued Memorandum Order No. 03, s. of 2016, on the "Revised Guidelines in Implementing Section 7 (j), (l) and Section 16 of Republic Act No. 8981, otherwise known as the 'PRC Modernization Act Of 2000', and the Pertinent Provisions of the Professional Regulatory Laws (PRLs), the General Agreement on Trade-in-Services (GATS), and other International Agreements on the Practice of Foreign Professionals in the Philippines";

WHEREAS, all Professional Regulatory Boards (Boards) are enjoined to appoint or designate, subject to the approval of the Commission, their respective Focal Persons who shall be primarily responsible for the evaluation of all STP applications that are lodged before the Board concerned and the Commission;

WHEREAS, the Board issued Resolution No. 01, s. of 2017 on the appointment or designation of **CONCORDIO S. QUISAOT**, Board Member, or in his absence, **SAMUEL B. PADILLA**, as the STP Board Focal Persons;

WHEREAS, the position of STP Focal Person was left vacant with the appointment of the replacement of **CONCORDIO S. QUISAOT** in the Board;

WHEREAS, the Professional Regulatory Board of Accountancy (Board) agreed, during its August 29, 2018 Board meeting, to designate **NOE G. QUIÑANOLA**, as the new alternate STP Board Focal Person;

IN VIEW WHEREOF, the Board hereby **RESOLVES** to recommend the appointment or designation of **SAMUEL B. PADILLA**, Board Member, or in his absence, **NOE G. QUIÑANOLA**, Board Chairman, as the STP Board Focal Persons.

RESOLVED FURTHER, that the conditions and limitations on the grant of the STP as set forth in Board Resolution No. 01, s. of 2017 shall remain valid and effective until otherwise amended or modified by the Board.

This Resolution shall take effect upon approval
