BOARD AND COMMISSION RATIFICATION OF ALL ISSUED CERTIFICATES OF NO-OBJECTION, CERTIFICATES OF NO-JURISDICTION AND CERTIFICATES OF NON-CONCURRENCE AS ACTED AND/OR DECIDED UPON BY THE BOARD FOCAL PERSON FOR JUNE 2018
