**RECONSTITUTION OF THE CONTINUING PROFESSIONAL DEVELOPMENT
COUNCIL (CPDC) FOR ACCOUNTANTS, AMENDING FOR THE PURPOSE BOARD
RESOLUTION NO. 24 (s 2018)**

WHEREAS, Republic Act (RA) No. 10912, otherwise known as the Continuing Professional Development Act of 2016, institutionalized the CPD requirement for all of the regulated professions;

WHEREAS, the Professional Regulation Commission issued Resolution No. 1032 (s 2017) on the Implementing Rules and Regulations (IRR) of RA No. 10912, known as the "Continuing Professional Development (CPD) Act of 2016" on February 15, 2017;

WHEREAS, Section 7 of RA No. 10912 and Section 7 of PRC Resolution No. 1032 (s 2017) provide for the composition of the CPD Council, namely, the Chairperson from the Board concerned; First (1st) Member from the Accredited Professional Organization/Accredited Integrated Professional Organization (APO/AIPO); and Second (2nd) Member from the national organization of deans or department heads of schools, colleges or universities offering any course requiring the licensure examination;

WHEREAS, the Professional Regulatory Board of Accountancy (Board) issued Resolution No. 24 (s 2018), and which was duly approved by the Commission, creating the CPD Council for Accountants;

WHEREAS, MARKO ROMEO L. FUENTES; has been chosen to be the new Chairman of the CPD Council for Accountants;

NOW THEREFORE, the Board **RESOLVES**, as it is hereby **RESOLVED**, to reconstitute the CPD Council for Accountants by designating **MARKO ROMEO L. FUENTES** as the Chairman of the CPD Council for Accountants;

FURTHER RESOLVED, that the Members of the CPD Council for Accountants herein constituted, namely:
