RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT FOR ONE (1) YEAR PROCUREMENT OF 24-HOUR SECURITY SERVICES FOR PRC REGIONAL OFFICE NO. I TO BELGIAN SECURITY AGENCY, INC. IN THE AMOUNT OF FIVE HUNDRED SIXTY-THREE THOUSAND THREE HUNDRED FIFTY-THREE PESOS AND 56/100 (P563,353.56)

WHEREAS, by virtue of the invitation to submit quotation posted at the website of the Commission, Philippine Government Electronic Procurement System (PhilGEPS), PRC Central Office Website (www.prc.gov.ph), PRC CAR Regional Website (prcbaguio.blogspot.com), and respective bulletin boards of PRC CAR, Baguio City Hall and PRC Regional Office No. I, 4V Investigation and Security Agency, Ranniag Security Services Inc. and Belgian Security Agency, Inc., participated in the Small Value Procurement for one (1) -year 24-hour Security Services for PRC Regional Office No. I WITH APPROVED BUDGET FOR THE CONTRACT OF FIVE HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED PESOS ONLY (P588,900.00);

WHEREAS, a Pre-bid Conference was held on March 12, 2019 at 10:00 AM at the PRC CAR Conference Room, which was attended by the representatives of Belgian Security Agency, Inc., Baguio Investigation and Security Agency and 4V Investigation and Security Agency;

WHEREAS, during the submission of quotation documents on March 25, 2019, one (1) sealed envelope with quotation documents was received from 4V Investigation and Security Agency at 6:50 AM. One (1) sealed envelope with quotation documents was received from Ranniag Security Services Inc. at 9:26 AM and one (1) sealed envelope received from Belgian Security Agency, Inc. at 1:15 PM. All quotations were dropped in the Bid Box before the deadline at 5:00 PM. The Bid Box containing the three (3) sealed envelopes were sealed by the RBAC Members at 5:05 PM.

WHEREAS, during the opening and evaluation of quotations on March 26, 2019 at 10:00 AM, the three (3) envelopes were opened by the RBAC Chairperson in the presence of RBAC members, RBAC secretariat, one (1) observer and one (1) representative from Belgian Security Agency, Inc;

WHEREAS, the Price Quotation Form received from Belgian Security Agency, Inc. with price quotation of P563,353.56 was declared as the Lowest Calculated Quotation. During the evaluation of its documentary requirements, Belgian Security Agency, Inc. was found to be responsive, thereby declaring it as the Lowest Calculated and Responsive Quotation;

WHEREFORE, the Regional Bids and Awards Committee **RESOLVES**, as it is hereby **RESOLVED**, to recommend to the Head of the Procuring Entity the award of Contract for one (1) -year Procurement of 24-hour Security Services for PRC Regional Office No. I to Belgian Security Agency, Inc. in the amount of FIVE HUNDRED SIXTY-THREE THOUSAND THREE HUNDRED FIFTY-THREE PESOS AND 56/100 (P563,353.56)
