BIDS AND AWARDS COMMITTEE Resolution No. 45

RECOMMENDING TO THE REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION FOR THE APPROVAL OF THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2019 TO DOUBLE DRAGON SECURITY FORCES AGENCY, INC. WITH A BID AMOUNT OF ONE MILLION FOUR HUNDRED THREE THOUSAND EIGHT HUNDRED NINETY FOUR PESOS AND NINETY SEVEN CENTAVOS (Php.1, 403, 894. 97)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, Double Dragon Security Forces Agency, Inc. and Proteger Security Agency Corp. participated in the Public Bidding for the project: Provision of Security Services 2019 with an approved budget for the contract of One Million Four Hundred Twenty Seven Thousand Six Seven Pesos and Thirty Six Centavos (Php.1,427, 067.36) only);

WHEREAS, on July 17, 2019, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have and was attended by Double Dragon Security Forces Agency, Inc. and ACD Security Agency;

WHEREAS, Double Dragon Security Forces Agency, Inc. and Proteger Security Agency Corp. purchased the bid documents.

WHEREAS, during the Opening of Bids on July 29, 2019 held at the Office of the Regional Director (RBAC Office), Double Dragon Security Forces Agency, Inc. and Proteger Security Agency Corp. submitted their respective bids containing their eligibility, technical, and financial requirements;

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed":

WHEREAS, Proteger failed in the eligibility and technical evaluation after having check of the said requirements. The RBAC chairman decided not to continue in opening their financial document.

WHEREAS, Double Dragon Security Forces Agency, Inc passed eligibility and technical evaluations and the RBAC opened the financial bid proposal with a bid price of ONE MILLION FOUR HUNDRED THREE THOUSAND EIGHT HUNDRED NINETY FOUR PESOS AND NINETY SEVEN CENTAVOS (Php 1, 403, 894. 97) and was declared to be the Single Calculated Bidder.

WHEREAS, on August 3, 2019 at 088 Purok Gemelina, National Highway, Sanito, Ipil, Zamboanga Sibugay, during the post qualification evaluation the RBAC sought to verify, validate the original and certified true copies of their Eligibility, Technical and Financial documents;

WHEREAS, Double Dragon Security Forces Agency, Inc., having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder;

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Regional Head of Procuring Entity of the Professional Regulation Commission, for his approval, the award of contract for the PROVISION OF SECURITY SERVICES 2019 to DOUBLE DRAGON SECURITY FORCES AGENCY, INC. with the bid amount of ONE MILLION FOUR HUNDRED THREE THOUSAND EIGHT HUNDRED NINETY FOUR PESOS AND NINETY SEVEN CENTAVOS (Php. 1, 403, 894. 97).
