WHEREAS, the Professional Regulatory Board of Accountancy (Board) approved the application of **BALICAS, LAMBOSO & CO.** for the practice of public accountancy and was issued Certificate of Accreditation bearing No. 0408 valid until **May 29, 2021** and was registered accordingly on the records of the Board and the Professional Regulation Commission (Commission);
