BOARD AND COMMISSION RATIFICATION OF ALL ISSUED CERTIFICATES OF NO-OBJECTION, CERTIFICATES OF NO-JURISDICTION AND CERTIFICATES OF NON-CONCURRENCE AS ACTED AND/OR DECIDED UPON BY THE BOARD FOCAL PERSON FOR OCTOBER 2019

WHEREAS, the Professional Regulation Commission (Commission) issued Memorandum Order No. 04 (s 2016) on the "Streamlining of Procedures in the Preparation of Board and Commission Resolutions and other Official Issuances Involving Policy Decisions and Directives; Actions and/or Decisions on Applications for the Licensure Examination, Registration Without Examination, Issuance of Certificates of Accreditation, Certificates of Compliance (COCs), Certificates of Authority to Operate, Certificates of Registration of Corporations and Partnerships for the Practice of Profession and other Similar Applications";

WHEREAS, Parts IV (2) and VII Category II (4) of Memorandum Order No. 4 (s 2016) provide that all actions and/or decisions of the Board Focal Person shall be subsequently ratified on a monthly basis by the Board and the Commission *en banc* through a Resolution issued for the purpose;

WHEREAS, the Commission issued Memorandum Order No. 18 (s 2017) on the "Internal Rules to Implement the Memorandum of Agreement between the Professional Regulation Commission (PRC) and Securities and Exchange Commission (SEC) on the Request for PRC's Comments and/or Recommendations on the Registration of Organizations/Associations with the SEC pursuant to Section 17, Title II of Batas Pambansa Blg. 68 or The Corporation Code of the Philippines".
