Resolution No. 2020 - 06(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF JANITORIAL SERVICES FOR CALENDAR YEAR 2020: LOT 1 - PROCUREMENT OF JANITORIAL SERVICES FOR THE CALENDAR YEAR 2020 FOR THE PRC OFFICES IN MORAYTA, PICC, AND NCR OFFSITE SERVICE CENTERS IN ROBINSONS PLACE MANILA, GALLERIA, NOVALICHES & LAS PIÑASTO D'TRIUMPH CLEANERS AND ALLIED SERVICES, INC. WITH THE TOTAL BID AMOUNT OF EIGHT MILLION EIGHT HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED TWELVE PESOS AND FORTY EIGHT CENTAVOS (Php.8,861,412.48)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the PRC website, Philippine Government Electronic Procurement System (PhilGEPS) website, and in the BAC Bulletin Board for the project: Procurement of Janitorial Services for Calendar Year 2020: Lot 1 - Procurement of Janitorial Services for the Calendar Year 2020 for the PRC Offices in Morayta, PICC, and NCR Offsite Service Centers in Robinsons Place Manila, Galleria, Novaliches & Las Piñas with an approved budget for the contract of Eight Million Eight Hundred Sixty Seven Thousand Pesos (Php.8,867,000.00).

WHEREAS, on January 7, 2020, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by four (4) prospective bidders namely, D'Triumph Cleaners and Allied Services, Inc. (D'Triumph), M8 Manpower Services (M8 Manpower), Benovolo Manpower Services Corporation (Benovolo Manpower), and One Merit Global Janitorial Services (One Merit). However, only D'Triumph purchased the bid documents.

WHEREAS, on January 14, 2020, a Bid Bulletin was issued by the BAC to give an additional set of Technical Parameters with corresponding weight percentage value and to inform the bidders of the new bidding schedule for the Opening of Bids.

WHEREAS, during the Opening of Bids on January 28, 2020, only D' Triumph submitted its bid containing their eligibility, technical, and financial requirements.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, D' Triumph having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal amounting to **EIGHT MILLION EIGHT HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED TWELVE PESOS AND FORTY EIGHT CENTAVOS (Php.8,861,412.48)**. Hence, D' Triumph was declared to be the Single Calculated Bidder and was subjected to post-qualification on January 30, 2020.

WHEREAS, during the post qualification, the BAC verified, validated, and ascertained all statements made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical, and Financial Envelopes, including the additional documentary requirements that will be submitted by the said bidder during post-qualification.

WHEREAS, D'Triumph, passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF JANITORIAL SERVICES FOR CALENDAR YEAR 2020: LOT 1 - PROCUREMENT OF JANITORIAL SERVICES FOR THE CALENDAR YEAR 2020 FOR THE PRC OFFICES IN MORAYTA, PICC, AND NCR OFFSITE SERVICE CENTERS IN ROBINSONS PLACE MANILA, GALLERIA, NOVALICHES & LAS PIÑAS** to **D'TRIUMPH CLEANERS AND ALLIED SERVICES, INC.** with bid amount of **EIGHT MILLION EIGHT HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED TWELVE PESOS AND FORTY EIGHT CENTAVOS (Php.8,861,412.48).**
