DECLARATION OF FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT: LOT 7 – FORTY-TWO (42) UNITS OF WIDESCREEN LCD TOUCHSCREEN MONITOR WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF SIX HUNDRED TWENTY-NINE THOUSAND NINE HUNDRED FIFTY-EIGHT PESOS (PHP629,958.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various IT Equipment: : Lot 7 – Forty-Two (42) Units Of Widescreen LCD Touchscreen Monitor with an approved budget for the contract of Six Hundred Twenty-Nine Thousand Nine Hundred Fifty-Eight Pesos (Php629,958.00) only.

WHEREAS, on September 28, 2020, during the schedule of submission and opening of bids, no bidder submitted a bid quotation for the said project. However, the BAC issued a Notice of Postponement and Rescheduling of Opening of Bids (Annex "A") which was posted in PRC Website, BAC Bulletin Board, and PhilGEPS.

WHEREAS, during the opening and evaluation of bids, on September 29, 2020, as there were no bids received therefor, this led to the declaration failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 <u>The BAC</u> shall declare the bidding a failure when:

a) No bids are received;

- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or postqualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35.3 of the same RIRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, <u>and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.(a)</u> (underscore supplied)

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE SUPPLY AND

DELIVERY OF VARIOUS IT EQUIPMENT: LOT 7 – FORTY-TWO (42) UNITS OF WIDESCREEN LCD TOUCHSCREEN MONITOR with a total approved budget for the contract of SIX HUNDRED TWENTY-NINE THOUSAND NINE HUNDRED FIFTY-EIGHT PESOS (PHP629,958.00). Consequently, the BAC shall conduct a rebidding with re-advertisement and/or posting of said procurement project.
