RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT: LOT 3 – TWENTY (20) PIECES WIFI ROUTER WITH SIM CARD SLOT WITH TOTAL BID AMOUNT OF ONE HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED FORTY PESOS (PHP139,240.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various IT Equipment: Lot 3 – Twenty (20) Pieces WIFI Router with Sim Card Slot with an approved budget for the contract of One Hundred Seventy-Seven Thousand One Hundred Four Pesos (Php177,104.00).

WHEREAS, on September 28, 2020, during the schedule of submission and opening of bids, only The Value Systems Phils., Inc. (Value Systems) submitted its eligibility, technical and financial quotation. However, the BAC issued a Notice of Postponement and Rescheduling of Opening of Bids (Annex "A") which was posted in PRC Website, BAC Bulletin Board, and PhilGEPS.

WHEREAS, on September 29, 2020, during the opening and evaluation of its bid, Value Systems passed the eligibility and technical evaluations, with financial bid quotation of One Hundred Thirty-Nine Thousand Two Hundred Forty Pesos (Php139,240.00).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, Value Systems was declared as the Single Calculated and Responsive Quotation.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT: LOT 3 – TWENTY (20) PIECES WIFI ROUTER WITH SIM CARD SLOT to VALUE SYSTEMS with bid amount of One Hundred Thirty-Nine Thousand Two Hundred Forty Pesos (Php139,240.00).
