## BIDS AND AWARDS COMMITTEE

Resolution No. 2020 <u>65</u>

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT:

LOT 9 – ONE HUNDRED FIFTY (150) UNITS OF BARCODE SCANNER/READER

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various IT Equipment: Lot 9 – One Hundred Fifty (150) Units of Barcode Scanner/Reader with Approved Budget for the Contract of Seven Hundred Fifty Thousand Pesos (Php750,000.00).

WHEREAS, during the scheduled deadline and submission of bid proposals on September 28, 2020, three bidders submitted their eligibility, technical and financial requirements, namely: Proximatech Solutions Company (Proximatech), Competitive Card Solutions Phils., Inc. (Competitive Card) and The Value Systems Phils., Inc. (Value Systems). However, the BAC issued a Notice of Postponement and Rescheduling of Opening of Bids (Annex "A") which was posted in PRC Website, BAC Bulletin Board, and PhilGEPS.

WHEREAS, on September 29, 2020, during the opening and evaluation of its bids, Proximatech failed to submit its Secretary's Certificate and was given a failed mark on its evaluation sheet thus declared to be disqualified while Competitive Card and Value Systems passed the eligibility and technical evaluations, with the following financial bid quotations:

- 1. Competitive Card Solutions Phils., Inc. P495,000.00
- 2. The Value Systems Phils., Ins. P566,550.00

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, Competitive Card was declared as the Lowest Calculated and Responsive Quotation.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT: LOT 9 – ONE HUNDRED FIFTY (150)
