RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE 2020 PRC AWARDING CEREMONY: LOT 1 – FIFTY (50) PIECES VARIOUS TROPHIES WITH TOTAL BID AMOUNT OF ONE HUNDRED TEN THOUSAND FOUR HUNDRED FIFTY PESOS (Php110,450.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various Tokens and Awards for the 2020 PRC Awarding Ceremony: Lot 1 – Fifty (50) Pieces Various Trophies with an approved budget for the contract of One Hundred Twelve Thousand Seven Hundred Sixty Pesos (Php112,760.00).

WHEREAS, on November 10, 2020, during the schedule of submission and opening of bids, only USB Manila Phils. Technologies Inc.(USB Manila) submitted its bid quotation.

WHEREAS, during the opening and evaluation of bid, USB Manila passed the eligibility and technical evaluations, with financial bid proposal of One Hundred Ten Thousand Four Hundred Fifty Pesos (Php110,450.00).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, USB Manila was declared to be the Single Calculated and Responsive Quotation.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: **SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE 2020 PRC AWARDING CEREMONY: LOT 1 – FIFTY (50) PIECES VARIOUS TROPHIES** with total bid amount of **ONE HUNDRED TEN THOUSAND FOUR HUNDRED FIFTY PESOS (Php110,450.00)**.
