**DECLARATION OF FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF  
VARIOUS AUDIO AND VISUAL ACCESSORIES AND SUPPLIES WITH A TOTAL  
APPROVED BUDGET FOR THE CONTRACT OF THIRTY-FIVE THOUSAND EIGHT  
HUNDRED TWENTY-SIX PESOS (PHP35,826.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and at the Bids Awards Committee (BAC) Bulletin Board for The Project: Supply and Delivery of Various Audio and Visual Accessories and Supplies with an approved budget for the contract of Thirty-Five Thousand Eight Hundred Twenty-Six Pesos (Php35,826.00) only.

**WHEREAS**, during the scheduled deadline and submission of bid proposals on June 14, 2021, no bidder submitted a proposal, thus, caused the failure of bidding for the project.

**WHEREAS**, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

**Section 35. Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)

**WHEREAS**, Section 35.3 of the same RIRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.<sup>(a)</sup> (underscore supplied)


**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS AUDIO AND VISUAL ACCESSORIES AND SUPPLIES** with a total approved budget for the contract of **THIRTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS (PHP35,826.00)**. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.


