Resolution No. <u>01</u> Series of 2022

## ADOPTION, ISSUANCE AND PROMULGATION OF THE REVISED TABLES OF SPECIFICATIONS FOR THE SUBJECTS IN THE CIVIL ENGINEERING LICENSURE EXAMINATIONS

**WHEREAS,** Section 9(h) of Republic Act (R.A.) No. 8981, known as the "PRC Modernization Act of 2000" empowers the Professional Regulatory Boards to prepare, adopt and issue the syllabi or **tables of specifications** of the subjects for examinations in consultation with the academe, and determine and prepare the questions for the licensure examinations which shall strictly be within the scope of the syllabus or **table of specifications** of the subject for examination;

**WHEREAS,** the Tables of Specifications (TOS) for the subjects in the Civil Engineering Licensure Examinations (CELE) shall be the basis for the test items to be encoded into the Test Questions Databank System;

**WHEREAS,** the said TOS shall include the competencies covering the topics and subtopics, the percentage weights and number of items as well as the levels of difficulty classified as follows: Easy (Remembering and Understanding), Moderate (Applying and Analyzing), and Difficult (Evaluating and Creating);



**WHEREAS,** the said TOS shall include the qualifications level descriptors defined in terms of knowledge, skills and values, application, and degree of independence referred to in Section 8 of R.A. No. 10968 or the "Philippine Qualifications Framework Act";

**WHEREAS,** the Professional Regulatory Board of Civil Engineering (Board), in compliance with R.A. No. 8981, conducted a public consultation with the Philippine Association of Engineering Schools, Inc.;

**WHEREAS,** the Board, with the guidance of the PRC Consultant for Test Construction and Development, formulated the TOS for implementation in the CELE;

**NOW THEREFORE,** the Board **RESOLVES,** as it is hereby **RESOLVED,** to adopt, issue and promulgate the Revised Tables of Specifications for the subjects in the Civil Engineering Licensure Examinations, marked as Annex "A" and made an integral part of this Resolution;

**RESOLVED FURTHER**, that this Resolution shall apply in the May 2022 Civil Engineering Licensure Examination and the subsequent schedules thereof.

This supersedes Resolution No. 12 (s. 2012), entitled "Promulgation of the Tables of Specifications (TOS) for the Subjects in the Board Licensure Examination for Civil Engineers".

This Resolution shall take effect immediately upon publication in the Official Gazette or in any newspaper of general circulation in the Philippines, copy furnished the U.P. Law Center.
