DECLARATION OF FAILURE OF BIDDING FOR THE PROJECT: LEASE OF VENUE (INCLUDING FOOD) FOR THE CONDUCT OF THE STRATEGIC DEVELOPMENT EXERCISE ON KEY RESULT AREAS AND KEY PERFORMANCE INDICATORS OF THE PROFESSIONAL REGULATION COMMISSION WITH THE PROFESSIONAL REGULATORY BOARDS WITH AN APPROVED BUDGET FOR THE CONTRACT OF SEVEN HUNDRED TWENTY THOUSAND SIX HUNDRED TWENTY-SIX PESOS AND 28/100 (PHP720,626.28)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.10 (Lease of Real Property and Venue) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 was posted in the website of the Commission and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Lease of Venue (including food) for the Conduct of the Strategic Development Exercise on Key Result Areas and Key Performance Indicators of the Professional Regulation Commission with the Professional Regulatory Boards with an approved budget for the contract of Seven Hundred Twenty Thousand Six Hundred Twenty-Six Pesos and 28/100 (Php720,626.28).

WHEREAS, several establishments from the preferred location of venue stated in the Terms of Reference (TOR) were also invited through electronic mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, only LUCKY STAR HOTELS AND RECREATION, INC., submitted a bid proposal.

WHEREAS, on 2 December 2022 at 8:15 in the morning during the evaluation of bids using a non-discretionary "pass/fail" criterion, the BAC declared **LUCKY STAR HOTELS AND RECREATION, INC. as disqualified** for non-submission of latest Income/Business Tax return and Secretary's Certificate that the person who submitted the bid quotation has authority to represent the organization, thus failure of bidding.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;***
- b) All prospective bidders are declared ineligible;***
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)***

WHEREAS, Sections 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms,

conditions, and specifications in the Bidding Documents, including its cost estimates.

35.3. *Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.*

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING** for the project: **LEASE OF VENUE (INCLUDING FOOD) FOR THE CONDUCT OF THE STRATEGIC DEVELOPMENT EXERCISE ON KEY RESULT AREAS AND KEY PERFORMANCE INDICATORS OF THE PROFESSIONAL REGULATION COMMISSION WITH THE PROFESSIONAL REGULATORY BOARDS** with an approved budget for the contract of Seven Hundred Twenty Thousand Six Hundred Twenty-Six Pesos and 28/100 (Php720,626.28).
