RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT FOR THE PROJECT: PROCUREMENT OF TEN (10) UNITS OF LAPTOP TO TERABIT COMPUTER SYSTEMS CORPORATION WITH TOTAL BID AMOUNT OF THREE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED PESOS (Php379,300.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Ten (10) Units Of Laptop with an approved budget for the contract of Four Hundred Ninety-Eight Thousand One Hundred Forty-Nine Pesos and Twenty Centavos (Php498,149.20).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, five (5) bidders participated and submitted their eligibility, technical, and financial proposals, namely, The Value Systems Integration Inc. (Value System), Terabit Computer Systems Corp. (Terabit), J1TEK Trading Corporation (J1TEK), CCP Computer Technologies Inc. (CCP), and DCI Int'l IT Solutions & Services Corp. (DCI).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on 20 December 2022, during the opening and evaluation of bids, using a non-discretionary "pass/fail" criterion, Value Systems was declared disqualified for submitting unnotarized Secretary's Certificate.

WHEREAS, Terabit, J1TEK, CCP, and DCI passed the eligibility and technical evaluation, with the following financial bid quotations:

- 1. Terabit Php379,300.00
- 2. J1TEK Php447,770.00
- 3. CCP Php430,000.00
- 4. DCI Php498,000.00

WHEREAS, Terabit was declared to be the Lowest Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: PROCUREMENT OF TEN (10) UNITS OF LAPTOP to TERABIT COMPUTER SYSTEMS CORPORATION with the total bid amount of THREE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED PESOS (Php379,300.00).
