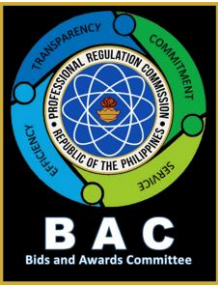

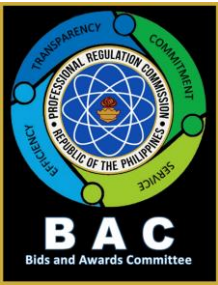

3.	<b>Certificates</b>  3.1. At least Four (4) VMware Certified Professionals 3.2. At least One (1) VMware Certified Advance Professional 3.3. At least One (1) VMware Certified Professional for Network Virtualization 3.4. Bidder must provide Certificate of Employment or letter from the Bidder's HR Department stating that the said engineers are employees of the bidder. 3.5. Bidder must provide Manufacturer's Certificate and Reseller Certificate. 3.7. VMware VTSP-BC Business continuity Certificate 5/5.8 3.8. Bidder must provide detailed Service Escalation Procedure, including hotline numbers. 3.9. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate.
2. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection.
3. A statement either in the Bidders statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the provisions of **ITB** Clause 4.
