**CHANGING THE MODALITY OF EXAMINATION FOR THE DECEMBER 2024
AERONAUTICAL ENGINEERS LICENSURE EXAMINATION FROM COMPUTER-BASED
LICENSURE EXAMINATION TO CONVENTIONAL PAPER-AND-PENCIL TEST**

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate;

WHEREAS, pursuant to Commission Resolution No. 1728 (s. 2023), the Aeronautical Engineers Licensure Examination (AELE) is scheduled on December 16, 17 and 18, 2024 in the National Capital Region (NCR) only;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024, wherein AELE will be conducted in the NCR only;

WHEREAS, the Commission issued Resolution No. 1868 (s. 2024) on the conduct of Computer-Based Licensure Examinations (CBLE) for the second half of the fiscal year (FY) 2024, wherein the December 2024 AELE will be conducted in the said modality;

WHEREAS, the Commission issued Resolution No. 1891 (s. 2024) increasing the number of testing venues for the examinations scheduled from October to December 2024, with the December 2024 AELE to be conducted in the NCR, Cagayan de Oro, Legazpi, Lucena, and Rosales;

WHEREAS, 1,091¹ examinees applied to take the December 2024 AELE;

WHEREAS, the Professional Regulatory Board of Aeronautical Engineering (Board) and the Licensure Office acknowledged the difficulty in conducting CBLE for such a huge number of examinees. For this reason, it has been recommended that the modality of the examination for the December 2024 AELE be changed from CBLE to conventional paper-and-pencil test;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CHANGE** the **MODALITY** of examination for the **December 2024 Aeronautical Engineers Licensure Examination** from CBLE to **CONVENTIONAL PAPER-AND-PENCIL TEST**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
