SCHEDULING THE FACE-TO-FACE ORAL EXAMINATION
FOR PROFESSIONAL MECHANICAL ENGINEERS
IN JEDDAH, KINGDOM OF SAUDI ARABIA

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the "PRC Modernization Act of 2000", authorizes the Professional Regulation Commission (Commission) to determine and fix the places and dates of examinations;

WHEREAS, Section 14 and 17 (a), Article III of R.A. No. 8495, or the "Philippine Mechanical Engineering Act of 1998", provides for the qualifications of applicants for the Professional Mechanical Engineer (PME). It is further provided that the granting of the PME Certificate of Registration shall be testimonial in nature which shall include the submission of an enumeration of the applicant's experience, including the presentation of an engineering report/technical paper pertinent to his/her line of experience attested to by two (2) or more PMEs in an affidavit for this purpose;

WHEREAS, Executive Order No. 835 dated October 6, 2009 was issued directing the Commission and other government agencies, through the Department of Labor and Employment, to conduct yearly Special Professional Board Licensure Examinations [herein referred to as *Special Professional Licensure Examinations (SPLE)*], when so warranted, in the Middle East countries;

WHEREAS, there are requests for the Professional Regulatory Board of Mechanical Engineering (Board) to hold the PME Oral Examination/Technical Evaluation in the Middle East;

WHEREAS, the Commission issued Resolution Nos. 1962 (s. 2025),¹ 1962 (A) (s. 2025),² 1975 (s. 2025),³ and Travel Order No. 238 (s. 2025)⁴ with regard to the conduct of the June 2025 SPLE;

IN VIEW OF THE FOREGOING, the Board **RESOLVES**, as it is hereby **RESOLVED**, to schedule the PME Oral Examination as follows:

The PME Oral Examination will be held at the WA Hotel in Jeddah, KSA.


