SCHEDULING THE FACE-TO-FACE ORAL EXAMINATION FOR
PROFESSIONAL MECHANICAL ENGINEERS

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981 or the “PRC Modernization Act of 2000” authorizes the Professional Regulation Commission (PRC/Commission) to determine and fix the places and dates of examinations;

WHEREAS, Section 14 and 17 (a) of R.A. No. 8495 or the “Philippine Mechanical Engineering Act of 1998” provides for the qualifications of applicants for the Professional Mechanical Engineer (PME) examination. It is further provided that the granting of the PME Certificate of Registration shall be testimonial in nature which shall include the submission of an enumeration of the applicant’s experience, including the presentation of an engineering report/technical paper pertinent to his/her line of experience attested to by two (2) or more PMEs in an affidavit for this purpose;

WHEREAS, the Professional Regulatory Board of Mechanical Engineering (Board) received requests to conduct the Face-to-Face Oral Examination for PMEs in various regions in the country;

IN VIEW OF THE FOREGOING, the Board **RESOLVES**, as it is hereby **RESOLVED**, to schedule the **Face-to-Face Oral Examination for Professional Mechanical Engineers** as follows:


