SCHEDULING THE TARGET DATE/S OF RELEASE OF EXAMINATION RESULTS
FOR THE JUNE 2025 SPECIAL PROFESSIONAL LICENSURE EXAMINATIONS
IN THE MIDDLE EAST COUNTRIES, SINGAPORE, AND TAIWAN

WHEREAS, pursuant to Republic Act (R.A.) No. 8981, also known as the “PRC Modernization Act of 2000”, and Executive Order No. 835 (s. 2009) directing the Professional Regulation Commission (PRC/Commission) and other concerned government agencies, through the Department of Labor and Employment, to conduct a yearly Special Professional Licensure Examination (SPLE) in the Kingdom of Saudi Arabia, Qatar, the United Arab Emirates, and other Middle East countries for the benefit of qualified Overseas Filipino Workers, the Commission issued Resolution No. 1962 (s. 2025) entitled, “Fixing the Dates and Places for the 2025 Special Professional Licensure Examinations (SPLE) for Overseas Filipino Workers (OFWs) in the Middle East Countries, Singapore and Taiwan”;

WHEREAS, there are thirty-one (31) professional licensure examinations to be administered in the Kingdom of Saudi Arabia (Al-Khobar, Jeddah and Riyadh), the United Arab Emirates (Abu-Dhabi and Dubai), Qatar, Kuwait, Bahrain, Singapore, and Taiwan on 06-08 June 2025;

WHEREAS, in addition to the written examinations, the Professional Mechanical Engineers Oral Examination is scheduled on 02-08 June 2025 in Jeddah;

WHEREAS, there is a need to set the target date/s for the release of the various professional licensure examination results included in the June 2025 SPLE;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to fix the target date/s for the release of the various licensure examination results included in the June 2025 SPLE as follows:
