**CONDUCTING FULL COMPUTER-BASED MODALITY IN THE NATIONAL CAPITAL REGION, CAGAYAN DE ORO, CEBU, DAVAO, ILOILO, LEGAZPI, LUCENA, AND ROSALES FOR THE JULY 2025 ENVIRONMENTAL PLANNERS LICENSURE EXAMINATION**

**WHEREAS**, Section 7 (d) of Republic Act (R.A.) No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

**WHEREAS**, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards and other operations of the Commission;

**WHEREAS**, the Commission initiated the project for the in-house Computer-Based Licensure Examinations (CBLE) towards the full computerization of the conduct of the various professional licensure examinations;

**WHEREAS**, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Environmental Planners Licensure Examination (EPL) on July 24 and 25, 2025 in the National Capital Region (NCR), Cagayan de Oro (CDO), Cebu, Davao, Iloilo, Legazpi, Lucena, and Rosales;

**WHEREAS**, all the above mentioned testing centers are CBLE-ready;

**WHEREAS**, the Professional Regulatory Board of Environmental Planning and Licensure Office recommend to conduct the July 2025 EPL through full computer-based modality.

**WHEREFORE**, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CONDUCT** the **ENVIRONMENTAL PLANNERS LICENSURE EXAMINATION** through **FULL COMPUTER-BASED MODALITY** in the **NCR, CDO, Cebu, Davao, Iloilo, Legazpi, Lucena, and Rosales on July 24 and 25, 2025**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
