CANCELLATION OF THE NURSES LICENSURE EXAMINATION IN CEBU, ILOILO, AND TACLOBAN ON NOVEMBER 04 AND 05, 2025 AND RESCHEDULING THE SAME TO NOVEMBER 06 AND 07, 2025

WHEREAS, Section 7(d) of Republic Act No. 8981, otherwise known as the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct licensure examinations of the various Professional Regulatory Boards, promulgate the necessary rules and regulations in connection therewith, and determine and fix the places and dates of said examinations;

WHEREAS, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Nurses Licensure Examination (NLE) on November 04 and 05, 2025 in various testing centers nationwide;

WHEREAS, the Commission issued Resolution No. 1178 (s. 2019), entitled "Revised Guidelines on the Suspension or Cancellation of Licensure Examination during Inclement Weather and Other Unexpected Disasters", in order to ensure the safety of examinees and examination personnel during inclement weather and other unexpected disasters;

WHEREAS, Resolution No. 1178 (s. 2019) provides that a declaration of Storm Signal No. 4 by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) will result in the automatic cancellation of a licensure examination;

WHEREAS, the cities of Cebu¹ and Iloilo² have been placed under Tropical Cyclone Wind Signal (TCWS) No. 4;

WHEREAS, as reported by the PRC Regional Office VIII (Tacloban), the prevailing unsafe weather conditions in the area have rendered the conduct of the NLE not feasible. In view of this, it has been recommended that the conduct of the NLE thereat be cancelled to safeguard the safety and well-being of the examinees and examination-personnel;

WHEREAS, the health, safety and well-being of examinees, and examination personnel remain the Commission's utmost priority and a main consideration in decisions involving the conduct of licensure examinations;

WHEREAS, the Professional Regulatory Board of Nursing and the Licensure Office recommended the cancellation of the NLE in **Cebu, Iloilo, and Tacloban on November 04 and 05, 2025** and the rescheduling thereof to **November 06 and 07, 2025**;

NOW, THEREFORE, premises considered, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CANCEL** the conduct of the **November 04 and 05, 2025 Nurses Licensure Examination in Cebu, Iloilo, and Tacloban** and to **RESCHEDULE** the same to **November 06 and 07, 2025**.
