**CANCELLATION OF THE NOVEMBER 2025 LANDSCAPE ARCHITECTS
COMPUTER-BASED LICENSURE EXAMINATION**

WHEREAS, Section 7(d) of Republic Act No. 8981, otherwise known as the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct licensure examinations of the various Professional Regulatory Boards, promulgate the necessary rules and regulations in connection therewith, and determine and fix the places and dates of said examinations;

WHEREAS, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Landscape Architects Licensure Examination (LALE) on July 17 and 18, 2025, to be conducted in the National Capital Region and Cebu;

WHEREAS, the Commission issued Resolution No. 2023 (s. 2025) approving the inclusion of a manual drawing component among the LALE subjects, and increasing the number of examination days of the LALE from two (2) days to three (3) days;

WHEREAS, the Commission subsequently issued Resolution No. 2024 (s. 2025), rescheduling the July 2025 LALE to November 27–29, 2025, due to the absence of a quorum necessary to conduct the said examination;

WHEREAS, Commission Resolution No. 2094 (s. 2025), entitled "Conduct of Computer-Based Licensure Examinations for October to December 2025" provided that the November 2025 LALE shall be conducted through a computer-based modality;

WHEREAS, during a consultative meeting with the Professional Regulatory Board of Landscape Architecture (Board), Test Consultants, and the Oversight Commissioner, it was agreed that the November 2025 LALE will be cancelled to allow the incoming Board Member(s) sufficient time for orientation and preparation for test construction;

WHEREAS, the Board and the Licensure Office have recommended the cancellation of the November 2025 LALE, and the transfer and acceptance of all approved and pending applications for this examination in the next schedule of the LALE in 2026, for final evaluation and approval;

NOW, THEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CANCEL** the **November 2025 Landscape Architects Computer-Based Licensure Examination**.

RESOLVED FURTHER, that all processed and approved examination applications, including those submitted prior to this cancellation, shall be **ACCEPTED** for the scheduled 2026 LALE, along with new applications, once the 2026 filing period for the LALE opens.

All concerned offices and divisions of the Commission are hereby directed to undertake the necessary coordination to ensure the smooth and orderly implementation of this Resolution.
