**DESIGNATING BAGUIO CITY AS AN ADDITIONAL TESTING CENTER FOR THE  
MAY 2026 ENVIRONMENTAL PLANNERS LICENSURE EXAMINATION**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the PRC Modernization Act of 2000 empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

**WHEREAS**, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards and other operations of the Commission;

**WHEREAS**, the Commission issued Resolution No. 2113 (s. 2025)<sup>1</sup>, which scheduled the Environmental Planners Licensure Examination (EPLE) on May 27 and 28, 2026 in the National Capital Region (NCR), Butuan, Cagayan de Oro, Cebu, Davao, Iloilo, Koronadal, Legazpi, Lucena, Rosales, and Tuguegarao;

**WHEREAS**, pursuant to the aforementioned resolution, the May 2026 EPLE will be conducted via computer-based modality;

**WHEREAS**, PRC Cordillera Administrative Region (CAR), through a letter dated 11 February 2026, requested the inclusion of its office as an additional testing center and manifested its readiness to support and facilitate the conduct of the examination;


**WHEREAS**, the Professional Regulatory Board of Environmental Planning and the Licensure Office recommend to designate Baguio as additional testing center for the May 2026 EPLE;

**NOW, THEREFORE**, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **DESIGNATE BAGUIO CITY** as an additional testing center for the **Environmental Planners Licensure Examination on May 27 and 28, 2026**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
