RESOLUTION NO. 2174

**DESIGNATING ROXAS CITY AS AN ADDITIONAL TESTING CENTER FOR THE
SEPTEMBER 2026 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**

WHEREAS, Section 7 (d) of Republic Act No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 2113 (s. 2025)¹ which scheduled the Licensure Examination for Professional Teachers (LEPT) on September 20, 2026 in various testing centers nationwide;

WHEREAS, the Commission received a request from the Office of the City Mayor (LGU) of Roxas to designate Roxas City, Capiz as a testing center for the September 2026 LEPT;

WHEREAS, Commission Resolution No. 1493 (s. 2022)² provides that additional testing centers for large-scale examinations outside the city or province where the PRC Regional Office is located must have at least three hundred (300) prospective examinees;

WHEREAS, the LEPT is a large-scale examination and there are 1,341 prospective examinees who will take the LEPT in Roxas City;

WHEREAS, the LGU of Roxas offered the use of public classrooms in Roxas City as examination venues;

WHEREAS, PRC Regional Office VI (PRC Iloilo) recommends the approval of the request to designate Roxas City, Capiz as an additional testing center for the September 2026 LEPT, to accommodate examinees from nearby areas and reduce the burden of long-distance travel;

WHEREAS, PRC Iloilo further endorsed and recommended the designation of Roxas City as an additional testing center as it has the necessary logistical and administrative capacity to conduct the LEPT thereat;

WHEREAS, the Professional Regulatory Board for Professional Teachers and the Licensure Office recommend to designate Roxas City as an additional testing center for the September 2026 LEPT;

NOW, THEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **DESIGNATE ROXAS CITY** as an additional testing center for the **Licensure Examination for Professional Teachers on September 20, 2026**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
