**REMOVING THE CITIES OF PAMPANGA AND TUGUEGARAO AS TESTING CENTERS
FOR THE JUNE 2026 PHYSICAL THERAPISTS LICENSURE EXAMINATION**

WHEREAS, Section 7 (d) of Republic Act No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, pursuant to Commission Resolution No. 2113 (s. 2025)¹, the Physical Therapists Licensure Examination (PTLE) is scheduled on June 02 and 03, 2026 in various testing centers nationwide, including Pampanga and Tuguegarao;

WHEREAS, the Commission issued Memorandum Order No. 35 (s. 2024)² allowing the PRC Regional Offices to request for cancellation of the conduct of a licensure examination in previously designated testing centers if there are less than fifty (50) examinees who applied thereat;

WHEREAS, the Licensure Office received requests from the PRC Regional Offices II (PRC Tuguegarao) and III (PRC Pampanga) to remove the Cities of Pampanga and Tuguegarao as testing centers for the June 2026 PTLE;

WHEREAS, only ten (10) applications were received in Pampanga and three (3) in Tuguegarao from applicants who manifested their intention to take the June 2026 PTLE;

WHEREAS, in consideration of cost efficiency, PRC Pampanga and PRC Tuguegarao requested the cancellation of the conduct of the June 2026 PTLE in their respective regions;

WHEREAS, the Professional Regulatory Board of Physical Therapy and the Licensure Office recommend to the Commission the cancellation of the conduct of the June 2026 PTLE in Pampanga and Tuguegarao;

NOW, THEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **REMOVE THE CITIES OF PAMPANGA AND TUGUEGARAO** as testing centers for the **June 2026 Physical Therapists Licensure Examination**.

RESOLVED FURTHER, that the PRC Regional Office II and III shall assist the affected examinees in transferring to other testing centers where they opt to take the examination.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
