DECLARATION OF FAILURE OF BIDDING FOR THE PROJECT: PRINTING AND SHREDDING OF TEST BOOKLETS FOR THE SEPTEMBER 26, 2021 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION FOUR HUNDRED SEVENTY TWO THOUSAND TWO HUNDRED PESOS (PHP2,472,200.00)

WHEREAS, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Printing and Shredding of Test Booklets for the September 26, 2021 Licensure Examination for Professional Teachers with an approved budget for the contract of Two Million Four Hundred Seventy Two Thousand Two Hundred Pesos (Php2,472,200.00).

WHEREAS, on July 23, 2021, a Pre-Bid Conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by a single prospective Bidder, Vibal Group, Inc.

WHEREAS, during the scheduled deadline and submission of bid proposals on August 4, 2021 at 10:00 o'clock in the morning, no bidder bought the bidding documents, thus, caused the failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 <u>The BAC</u> shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or postqualification, or x x x (Emphasis supplied)

WHEREAS, Section 35.3 of the same RIRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of this IRR. (underscore supplied)

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the project: PRINTING AND SHREDDING OF TEST BOOKLETS FOR THE SEPTEMBER 26, 2021 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION FOUR HUNDRED SEVENTY TWO THOUSAND TWO HUNDRED PESOS (PHP2,472,200.00).
