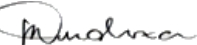

19.	<p>The applicable rate is one tenth (1/10) of one (1) percent of the cost of the unperformed portion, if the value of the said portion is incapable of immediate pecuniary estimation. The Procuring Entity shall consider the bid price as the basis for the above rate, for every day of delay.</p> <p><b><u>However, in case of default on the part of the Contractor, the Procuring Entity shall be entitled to the maximum deduction of ten percent (10%) of the approved amount of contract.</u></b> Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity shall rescind the contract, without prejudice to other courses of action and remedies available.</p>
