Resolution No. 2021 - **55(A)** 

DECLARING OF FAILURE OF BIDDING FOR THE PROJECT: SUPPLY AND DELIVERY OF BROTHER TONER TN 3448 (ORIGINAL) COMPATIBLE WITH HL-L6400DW HIGH VOLUME MONOCHROME LASER PRINTER WITH TOTAL APPROVED BUDGET FOR THE CONTRACT OF SEVEN HUNDRED SEVEN THOUSAND TWO HUNDRED PESOS (PHP707,200.00)

**WHEREAS**, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Brother Toner TN 3448 (Original) Compatible with HL-L6400DW High Volume Monochrome Laser Printer with an approved budget for the contract of Seven Hundred Seven Thousand Two Hundred Pesos (Php707,200.00).

**WHEREAS**, on October 11, 2021 a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

**WHEREAS**, on October 27, 2021, a Pre-Bid Conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective Bidder namely: Business Machines Corp.

**WHEREAS**, On October 28, 2021, the BAC issued Bid Bulletin No. 1 (Annex "A") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference.

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on November 8, 2021 during the submission and opening of bids, only Business Machine Corp. submitted its bidding documents. Upon evaluation thereof using the non-discretionary "pass/fail" criterion, BAC gave Business Machine Corp. a failed mark for not complying on the Financial Eligibility Requirement. Business Machines Corp. failed to submit its Audited Financial Statement and its Net Financial Contracting Capacity (NFCC).

**WHEREAS,** Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) No. 9184, states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

### Section 35. Failure of Bidding

- 35.1 The BAC shall declare the bidding a failure when:
  - a) No bids are received:
  - b) All prospective bidders are declared ineligible;
  - c) All bids fail to comply with all the bid requirements or postqualification, or x x x x (Emphasis supplied)

**WHEREAS,** Section 35 of the same RIRR also provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it is hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the project: Supply and Delivery of Brother Toner TN 3448 (Original) Compatible with HL-L6400DW High Volume Monochrome Laser Printer with total approved budget for the contract of SEVEN HUNDRED SEVEN THOUSAND TWO HUNDRED PESOS (PHP707,200.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.


