DECLARING OF FAILURE OF BIDDING FOR THE PROJECT: SUPPLY, DELIVERY, INSTALLATION AND TESTING OF RACKMOUNT SERVER FOR THE DATABASE CLEANSING AND MANAGEMENT PROJECT – REBID WITH TOTAL APPROVED BUDGET FOR THE CONTRACT OF EIGTH HUNDRED TOUSAND PESOS (PHP800,000.00)

WHEREAS, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply, Delivery, Installation and Testing of Rackmount Server for the Database Cleansing and Management Project – Rebid with an approved budget for the contract of Eight Hundred Thousand Pesos (Php800,000.00).

WHEREAS, on October 15, 2021 a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on October 29, 2021, a Pre-Bid Conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by five (5) prospective Bidders namely: 3Core Leaderstech Corp., Advance Solutions Inc., Macrologic Diversified Technologies, Inc., American Technologies Inc., and Integrated Computer Systems Inc.

WHEREAS, On November 2, 2021, the BAC issued Bid Bulletin No. 1 (Annex "A") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference.

WHEREAS, on November 11, 2021, during the submission and opening of bid, no bidder submitted bid; thereby, causing the failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) No. 9184, states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or postqualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35 of the same RIRR also provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it is hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the project: Supply, Delivery, Installation and Testing of Rackmount Server for the Database Cleansing and Management Project — Rebid with total approved budget for the contract of EIGHT HUNDRED THOUSAND PESOS (PHP800,000.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.


