



**CONTINUING PROFESSIONAL DEVELOPMENT (CPD)
COUNCIL OF VETERINARY MEDICINE**

**SUBMISSION OF ABSTRACT AS AN ADDITIONAL REQUIREMENTS
FOR ACCREDITATION OF CONTINUING PROFESSIONAL
DEVELOPMENT(CPD) PROGRAM**

WHEREAS, Section 6, Article II of Republic Act (R.A.) No. 10912 or the "Continuing Professional Development Act of 2016" vests to the Professional Regulation Commission (Commission) and the Professional Regulatory Boards (Boards) the power to formulate, issue, and promulgate guidelines and procedures for the implementation of the CPD Programs and the organization of CPD Councils for each of the regulated professions.

WHEREAS, Section 8.8.5 of Commission Resolution No. 1032 (s. 2017), otherwise known as the "Implementing Rules and Regulations (IRR) of R.A No. 10912", provides that the CPD Council has the power to assess and/or upgrade the criteria for accreditation of CPD Providers and their CPD Programs on a regular basis;

WHEREAS, Section 5 of Board of Veterinary Medicine Resolution No. 09 (s. 2019), otherwise known as the Operational Guidelines for the Veterinary Medicine Profession during the Transition Period, pursuant to Commission Resolution No. 1146 (s. 2019), entitled "Amending Relevant Provisions of Resolution No. 1032 (s. 2017), or the IRR of R.A.No. 10912, states that any accredited CPD Provider may apply for accreditation of its program to the CPD Council of Veterinary Medicine subject to the approval of the CPD Council after evaluation on its relevance, value and/or applicability of the program to the Veterinary Medicine profession as basis for the grant of CPD credit units;

WHEREAS, Annex "B-4" of Commission Resolution No. 1244 (s. 2020), otherwise known as Guidelines on the Matrix of CPD Activities, Revised CPD Forms, and CPD Glossary stipulates that the CPD Council shall have the right to specify additional requirements if deemed necessary and appropriate;

WHEREAS, the CPD Council of Veterinary Medicine (Council) during content and technical evaluation of submitted documentary requirements for accreditation of CPD Programs consistently observed the following deficiencies:

1. Proposed learning outcomes do not support Philippine Qualification Framework (PQF) domain descriptor level 6;
2. Unclear alignment of course content and learning outcomes; and
3. Unidentified essential and enduring understanding that must be learned by the registered veterinarians.

WHEREAS, in order to address the above-enumerated deficiencies, the Council, in consultation with the Board of Veterinary Medicine, finds it deemed necessary to require accredited CPD Providers of Veterinary Medicine profession the submission of abstract as an additional documentary requirements for accreditation of CPD Programs.

WHEREAS, to ensure uniformity of abstract submission in terms of content and format, the Council prescribes the template hereto attached as **Annex A**.


NOW THEREFORE, the CPD Council of Veterinary Medicine, with the approval of the Board of Veterinary Medicine, hereby **RESOLVED** as it is now **RESOLVES** to issue this Resolution to necessitate the submission of abstract as an additional documentary requirements for accreditation of CPD Programs for the Veterinary Medicine profession.


Let a copy of this declaration be furnished to all accredited CPD Providers of Veterinary Medicine profession and concerned PRC offices, for information and compliance.
