This Contract made and entered into by and between:

(TIGER CONSULTING), a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at 17Q Burgundy Corporate Tower 252 Sen Gil Puyat Avenue, Makati City, herein represented by its Managing Director, MR. DENNIS LIM.

## WITNESSETH THAT:
