Relative to this, all examinees of Davao City are required to bring following:

1. **Notice of Admission**
2. **One (1) piece metered-stamped window mailing envelope**
3. **Two (2) or more pencils (NO. 2)**
4. **Ball pens with BLACK ink only**
5. **One (1) piece long brown envelope**
6. **One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)**
7. **Calculators with the following features only- addition, subtraction, multiplication, division, trigonometric function, logarithm and x^y .**
8. **For pregnant examinee, submit clearance from the OB-Gynecologists**
 - ❖ **Clearance should indicate that the examinee is cleared to take the licensure examination. No OB-Gyne Clearance, No Exam**
9. **Snacks and lunch packed in transparent containers.**
 - ❖ **Food deliveries are not allowed.**
 - ❖ **Schools, review center, co-examinees, or any other group are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.**
